

VICTORIAN ENVIRONMENTAL WATER HOLDER
SEASONAL WATERING STATEMENT #5 FOR
NORTH CENTRAL CATCHMENT MANAGEMENT AUTHORITY 2021-22
BOORT WETLANDS: LAKE LEAGHUR, LAKE MERAN

The Victorian Environmental Water Holder makes the following seasonal watering statement under section 33DY of the *Water Act 1989*.

1. PURPOSE

This seasonal watering statement authorises North Central Catchment Management Authority to use water from the Water Holdings at Lake Leaghur and Lake Meran to achieve environmental objectives and expected watering effects specified in section 5.7.2 of the *Seasonal Watering Plan 2021-22* and for emergency environmental watering in accordance with section 1.3.7 of the *Seasonal Watering Plan 2021-22*.

2. DURATION OF APPROVAL

This seasonal watering statement is valid from 1 July 2021 to 31 December 2021, unless superseded by another seasonal watering statement or revoked by the Victorian Environmental Water Holder.

3. AUTHORISATION TO USE THE WATER HOLDINGS

North Central Catchment Management Authority is authorised to use up to 4,900 ML of water from the Water Holdings in the two wetlands listed in Schedule 1.

This water is made available by the Victorian Environmental Water Holder and can be used under the *Bulk Entitlement (Loddon River – Environmental Reserve) Order 2005* (allocation accounts 067057, 043412, 093407 and 043413), *Goulburn River Environmental Entitlement 2010* (allocation account 067058) and the *Environmental Entitlement (Goulburn System – NVIRP Stage 1) 2012* (allocation account 088041) held by the Victorian Environmental Water Holder.

Water is to be delivered under the provisions of the entitlement and in accordance with the potential environmental watering actions specified in Table 5.7.3 of the *Seasonal Watering Plan 2021-22* or the emergency watering procedure in section 1.3.7 of the *Seasonal Watering Plan 2021-22*. The potential watering actions authorised are those that are denoted as tier 1a under the dry and average scenarios in Table 5.7.4 of the *Seasonal Watering Plan 2021-22*.

This authorisation is subject to:

- (a) consultation with Victorian Environmental Water Holder to ensure the availability of sufficient water in the Water Holdings to which this statement applies and the appropriate allocation account to order water from
- (b) endorsement of delivery plans (for individual wetlands listed in Schedule 1) by the Victorian Environmental Water Holder and implementation of the conditions and risk mitigating strategies of the endorsed delivery plans and in line with section 1.3.6 of the *Seasonal Watering Plan 2021-22*
- (c) an agreement for watering private land where required, endorsed by the Victorian Environmental Water Holder
- (d) implementation of the risk mitigating strategies identified in North Central Catchment Management Authority's *Seasonal Watering Proposal Loddon Murray Wetlands 2021-22* and in line with section 1.3.6 of the *Seasonal Watering Plan 2021-22*

(e) reporting to the Victorian Environmental Water Holder on implementation of this seasonal watering statement.
