

VICTORIAN ENVIRONMENTAL WATER HOLDER
SEASONAL WATERING STATEMENT #7 FOR
NORTH CENTRAL CATCHMENT MANAGEMENT AUTHORITY 2022-23
CENTRAL MURRAY WETLANDS

The Victorian Environmental Water Holder makes the following seasonal watering statement under section 33DY of the *Water Act 1989*.

1. PURPOSE

This seasonal watering statement authorises North Central Catchment Management Authority to use water from the Water Holdings at Guttrum Forest, Johnson Swamp, Kunat Kunat (Round Lake), Lake Cullen, Lake Elizabeth, McDonalds Swamp, Muringa Wetlands (North and South), Richardson's Lagoon, and Wirra-lo Wetland complex (Lignum Swamp North/South, Duck Creek North, Red Gum Swamp, Cattleyard Creek, Emu Creek, Bunyip Swamp East and Bunyip Swamp West) to achieve environmental objectives and expected watering effects specified in section 5.2.4 of the *Seasonal Watering Plan 2022-23* and for emergency environmental watering in accordance with section 1.3.7 of the *Seasonal Watering Plan 2022-23*.

2. DURATION OF APPROVAL

This seasonal watering statement is valid from 1 July 2022 to 31 December 2022, unless superseded by another seasonal watering statement or revoked by the Victorian Environmental Water Holder.

3. AUTHORISATION TO USE THE WATER HOLDINGS

North Central CMA is authorised to use up to 15,850 ML of water from the Water Holdings in the nine wetlands listed in Schedule 1.

This water is made available by the Victorian Environmental Water Holder and can be used under the *Bulk Entitlement (River Murray – Flora and Fauna) Conversion Order 1999* (allocation accounts 043265, 094002, 108634, 108633, 108632 and 068158) and *Environmental Entitlement (River Murray – NVIRP Stage 1) 2012* (allocation account 088036) held by the Victorian Environmental Water Holder.

Water is to be delivered under the provisions of the entitlement and in accordance with the potential environmental watering actions specified in Table 5.2.10 of the *Seasonal Watering Plan 2022-23* or the emergency watering procedure in section 1.3.7 of the *Seasonal Watering Plan 2022-23*.

This authorisation is subject to:

- (a) consultation with Victorian Environmental Water Holder to ensure the availability of sufficient water in the Water Holdings to which this statement applies and the appropriate allocation account to order water from
- (b) endorsement of delivery plans (for individual wetlands listed in Schedule 1) by the Victorian Environmental Water Holder and implementation of the conditions and risk mitigating strategies of the endorsed delivery plans and in line with section 1.3.6 of the *Seasonal Watering Plan 2022-23*
- (c) an agreement for watering private land where required, endorsed by the Victorian Environmental Water Holder
- (d) implementation of the risk mitigating strategies identified in North Central CMA's *Guttrum Forest Seasonal Watering Proposal 2022-23* and *Central Murray Wetlands*

Seasonal Watering Proposal 2022-23 and in line with section 1.3.6 of the Seasonal Watering Plan 2022-23

- (e) reporting to the Victorian Environmental Water Holder on implementation of this seasonal watering statement.
