

VICTORIAN ENVIRONMENTAL WATER HOLDER
SEASONAL WATERING STATEMENT #2A FOR
WIMMERA CATCHMENT MANAGEMENT AUTHORITY 2026-27
WIMMERA MALLEE WETLANDS

The Victorian Environmental Water Holder makes the following seasonal watering statement under section 33DY of the *Water Act 1989*.

1. PURPOSE

This seasonal watering statement authorises Wimmera Catchment Management Authority to use water from the Water Holdings in the Wimmera Mallee wetlands to achieve environmental objectives and expected watering effects specified in section 4.4 of the *Seasonal Watering Plan 2026-27* and for emergency environmental watering in accordance with section 1.2.8 of the *Seasonal Watering Plan 2026-27*.

2. DURATION OF APPROVAL

This seasonal watering statement is valid from 24 August 2026 to 30 June 2027, unless superseded by another seasonal watering statement or revoked by the Victorian Environmental Water Holder.

3. AUTHORISATION TO USE THE WATER HOLDINGS

Wimmera Catchment Management Authority is authorised to use up to 36 ML of water from the Water Holdings in the 11 wetlands listed in Schedule 1.

This water is made available by the Victorian Environmental Water Holder and can be used under the *Wimmera and Glenelg Rivers Environmental Entitlement 2010* (allocation account 085417) held by the Victorian Environmental Water Holder.

Water is to be delivered under the provisions of the entitlement and in accordance with the potential environmental watering actions specified in Table 4.4.1 of the *Seasonal Watering Plan 2026-27* or the emergency watering procedure in section 1.2.8 of the *Seasonal Watering Plan 2026-27*.

This seasonal watering statement supersedes Seasonal Watering Statement #2 for Wimmera Catchment Management Authority 2026-27 and the total volume authorised includes water used under that seasonal watering statement between 1 July 2026 and 23 August 2026.

This authorisation is subject to:

- (a) consultation with Victorian Environmental Water Holder to ensure the availability of sufficient water in the Water Holdings to which this statement applies and the appropriate allocation account to order water from
- (b) endorsement of a delivery plan for the wetlands listed in Schedule 1 by the Victorian Environmental Water Holder and implementation of the conditions and risk mitigating strategies of the endorsed delivery plan and in line with section 1.2.7 of the *Seasonal Watering Plan 2026-27*
- (c) an agreement for watering private land where required, endorsed by the Victorian Environmental Water Holder
- (d) confirmation by the Victorian Environmental Water Holder that the costs of the watering action/s to which this statement applies can be supported.

- (e) reporting to the Victorian Environmental Water Holder on implementation of this seasonal watering statement.
