

**VICTORIAN ENVIRONMENTAL WATER HOLDER**  
**SEASONAL WATERING STATEMENT #1A FOR**  
**GOULBURN BROKEN CATCHMENT MANAGEMENT AUTHORITY 2025-26**  
**GOULBURN WETLANDS: DOCTORS SWAMP, HORSESHOE LAGOON, KANYAPELLA**  
**BASIN AND LOCH GARRY**

The Victorian Environmental Water Holder makes the following seasonal watering statement under section 33DY of the *Water Act 1989*.

**PURPOSE**

This seasonal watering statement authorises Goulburn Broken Catchment Management Authority to use water from the Water Holdings at Doctors Swamp, Horseshoe Lagoon, Kanyapella Basin and Loch Garry to achieve environmental objectives and expected watering effects specified in section 5.4.2 of the *Seasonal Watering Plan 2025-26* and for emergency environmental watering in accordance with section 1.2.8 of the *Seasonal Watering Plan 2025-26*.

**DURATION OF APPROVAL**

This seasonal watering statement is valid from 24 July 2025 to 30 June 2026, unless superseded by another seasonal watering statement or revoked by the Victorian Environmental Water Holder.

**AUTHORISATION TO USE THE WATER HOLDINGS**

Goulburn Broken Catchment Management Authority is authorised to use up to 4,200 ML of water from the Water Holdings in the two wetlands listed in Schedule 1.

This water is made available by the Victorian Environmental Water Holder and can be used under the *Environmental entitlement (Goulburn River) 2010* (allocation accounts 093999, 094000, 108627, 108628) held by the Victorian Environmental Water Holder.

Water is to be delivered under the provisions of the entitlement and in accordance with the potential environmental watering actions specified in Table 5.4.4 of the *Seasonal Watering Plan 2025-26* or the emergency watering procedure in section 1.2.8 of the *Seasonal Watering Plan 2025-26*.

This seasonal watering statement supersedes *Seasonal Watering Statement #1 for Goulburn Broken Catchment Management Authority 2025-26*, and the total volume authorised includes water used under that seasonal watering statement between 1 July 2025 and 24 July 2025.

This authorisation is subject to:

- (a) consultation with Victorian Environmental Water Holder to ensure the availability of sufficient water in the Water Holdings to which this statement applies and the appropriate allocation account to order water from
- (b) endorsement of a delivery plan (for individual wetland listed in Schedule 1) by the Victorian Environmental Water Holder and implementation of the conditions and risk mitigating strategies of the endorsed delivery plans and in line with section 1.2.7 of the *Seasonal Watering Plan 2025-26*
- (c) confirmation by the Victorian Environmental Water Holder that the costs of the watering action/s to which this statement applies can be supported.

- (d) reporting to the Victorian Environmental Water Holder on implementation of this seasonal watering statement.
